2. PAO has reported Rs.17,33,14,430/- as refunded amount due to failed transactions during the month of April 2024 to May 2024. The refunded amount will be bifurcated as SC: Rs.17,33,14,430/-, ST: Rs.0/- and OTH: Rs.0/- The residual amount of Rs.75,86,27,505/- [(ST: Rs.5,55,66,764/-), (SC: Rs.60,48,19,404/-), & (Others: Rs.9,82,41,337/-)] vide Mother Sanction Order of even No. Dated 24/06/2024 (U.O. No.49/Finance/2024-25) has been carried forward into the current Mother Sanction Order for the purpose of utilizing the funds. Hence the total amount available for release to the State for wages Rs.606,69,41,935/- [Rs.513,50,00,000/- (current Mother Sanction) + Rs.75,86,27,505/-(Residual amount of previous mother Sanction) + Rs.17,33,14,430/- (re-initiated amount of failed transactions.
