Hence the total amount available for release to the State for wages Rs.606,69,41,935/-[Rs.513,50,00,000/- (current Mother Sanction) + Rs.75,86,27,505/-(Residual amount of previous mother Sanction) + Rs.17,33,14,430/- (re-initiated amount of failed transactions.
