No.95 dated 01/08/2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-2025.


2. The residual amount of **Rs.95,67,15,369/- [(SC: Rs.85,11,52,286/-), (ST: Rs.6,06,29,110/-), & (Others: Rs.4,49,33,973/-)]** vide Mother Sanction Order of even No. Dated 24/07/2024 (U.O. No.263/Finance/2024-25) has been carried forward into the current Mother Sanction Order for the purpose of utilizing the funds. Hence the **total amount available for release to the State for wages Rs.2612,87,40,369/- [Rs.2517,20,25,000/- (current Mother Sanction) + Rs.95,67,15,369/- (Residual amount of previous mother Sanction)]**.

3. The total amount of **Rs.2279,67,66,008/-** is distributed among different categories of beneficiaries as under:-

5. Further installment of the remaining sanctioned amount would be released as per FTOs entered in MIS by State Government and reflected in PFMS.
6. The grant in towards plan expenditure and will be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGA Guidelines Issued from time to time. No deviation from the provisions of these Guidelines is permissible.
7. All other terms and conditions mentioned in Mother Sanction Order No J-14037/01/2025-RE-I (387669) Sl. No.95 of even number dated 01.08.2024 shall remain the same.
8. The DDO, MGNREGA, New Delhi (207172), Ministry of Rural Development will be the Drawing & Disbursing Officer for the purpose.
9. The amount mentioned in Para -1 above will be transferred to State Employment Guarantee Fund in **Account No.35638070871** in the State Bank of India, Branch- Jawahar Bhavan, Lucknow, **Branch Code No.006144 and Branch IFSC- SBIN0006144.**


