2. The residual amount of Rs.95,67,15,369/- [(SC: Rs.85,11,52,286/-), (ST: Rs.6,06,29,110/-), & (Others: Rs.4,49,33,973/-)] vide Mother Sanction Order of even No. Dated 24/07/2024 (U.O. No.263/Finance/2024-25) has been carried forward into the current Mother Sanction Order for the purpose of utilizing the funds. Hence the total amount available for release to the State for wages Rs.2612,87,40,369/-[Rs.2517,20,25,000/- (current Mother Sanction) + Rs.95,67,15,369/-(Residual amount of previous mother Sanction).
