

No.150 dated 29/11/2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-2025

No. 77/Finance/2024-25) has been carried forward into the current Mother Sanction Order for the purpose of utilizing the funds. Hence the total amount available for release to the State for wages Rs.413,01,38,671/-[Rs.396,66,66,848/- (current Mother Sanction) + Rs.6,98,69,456/-(Residual amount of previous mother Sanction) + Rs.17,33,14,430/- (re-initiated amount of failed transactions.
