No.150 dated 29/11/2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-2025

- 2. PAO has reported Rs.9,36,02,367/- as refunded amount due to failed transactions during the month of June, 2024 to October, 2024. The refunded amount will be bifurcated as Oth: Rs.9,36,02,367/-, ST: Rs.0/- and SC: Rs.0/-.
