- 9. The amount mentioned in Para -1 above will be transferred to State Employment Guarantee Fund (NeFMS) in Account No.42859032171 in the State Bank of India, Branch-Imphal Secretariat, Branch Code No.004562 and Branch IFSC-SBIN0004562.
