Sir/Madam,

I am directed to convey the sanction of the President of India to the payment of Grants-in-aid amounting to **Rs.5,21,37,500/- (Rupees Five Crore Twenty One Lakh Thirty Seven Thousand and Five Hundred Only)** as 2<sup>nd</sup> Installment of 2<sup>nd</sup> tranche for the Financial Year **2024-25** to the State Government of Telangana as Central Assistance towards conducting Social Audit in the State & Staffing of Independent Social Audit Unit.

2. The State Government must transfer these funds to the Social Audit Units Bank account within 15 days of receipt of these funds. In cases of non transfer beyond this period, The State Government would be liable to pay interest @ 12% per annum for the period of delay beyond the specified period.
