I am directed to convey the sanction of the President of India to the payment of Grants-in-aid amounting to **Rs.3,34,55,660/- (Rupees Three Crore Thirty Four Lakh Fifty Five Thousand Six Hundred and Sixty Only)** as part of 2<sup>nd</sup> installment of 1<sup>st</sup> Tranche to the State Government of Andhra Pradesh as Central assistance towards conducting Social Audit in the State & Staffing of Independent Social Audit Unit for the financial year 2024-25.

In case of non-transfer beyond this period, the State Government would be liable to pay interest @ 12% per annum for the period of delay beyond the specified period. 6. The Utilization Certificate should be submitted within 12 months of the closure of financial year which shall include interest accrued. Interest accrued should be computed based on the details of ledger account maintained for the purpose.
