7. Further fund would be released on compliance of all conditions prescribed at the time of previous releases and submission of compliance on minutes of the Labour Budget meeting for FY 2024-25 at the earliest within the stipulated time.

No Utilization Certificate is pending against the Recipient Organization under the Scheme. 8.

The Utilization Certificate should be submitted within 12 (twelve) months of the closure of financial year 9 which shall include interest accrued. Interest accrued should be computed based on the details of ledger account maintained for the purpose. Interest accrued, if any should be returned to Government of India.

The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and 10. the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 236 (1) of the General Financial Rules, 2017.
