Sir,

I am directed to convey the sanction of the President of India for release of an amount of **Rs.2,45,71,740/- (Rupees Two Crore Forty Five Lakh Seventy One Thousand Seven Hundred and Forty Only)** to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of State of Odisha as 117th Installment out of the sanctioned amount of **Rs.1223,10,07,000/- (Rupees One Thousand Two Hundred and Twenty Three Crore Ten Lakh Seven Thousand Only)** vide Mother sanction order No. L-15060/03/2024-RE-VII/Sl.No.17 dated 06.04.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

3. The payment under DBT are linked to the FTOs generated based on primary records retained at GP/Block level and therefore the accounts/primary records will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry of Rural Development in terms of Rule 236(1) of the General Financial Rules 2017.

4. Further installment of the remaining sanctioned amount would be released as per FTOs entered in MIS by State Government and reflected in PFMS.

5. The grant in towards plan expenditure and will be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGA Guidelines Issued from time to time. No deviation from the provisions of these Guidelines is permissible.

6. All other terms and conditions mentioned in Mother Sanction order No.L-15060/03/2024-RE-VII/Sl.No.17dated 06.04.2024shall remain the same.

7. The DDO, MGNREGA, New Delhi (207172), Ministry of Rural Development will be the Drawing & Disbursing Officer for the purpose.

8. The amount mentioned in Para -1 above will be transferred to the State Employment Guarantee fund of Government of Odisha in Account No.35612114539 in the bank State Bank of India, Branch, Secretariat Branch, Bhubaneswar , and Branch IFSC SBIN0010236.

9. Keeping in view the imposition of model code of conduct in the light of General Election of 2024, the sanction is subject to following condition:

i. Absolutely no publicity in this regard shall be made in electronic, print, radio and internet or any other media, in any from whatsoever.

ii. No political functionary shall make any reference in this regard during any publice speech or communication to the press or public.

iii. These restrictions on publicity will be applicable on both i.e. Central Government as well as the State Government.

iv. The relevant provisions of Model Code of Conduct issued by the Election Commission shall be strictly followed.

10. This issue under the powers delegated to this Ministry and in consultation with the Integrated Finance Division vide their 19/Finance/2024-25 dated 05.04.2024.
